Pink Therapy offers an accreditation scheme for qualified therapists working with gender, sex & relationship diversities (GSRD) clients. There are two categories of accreditation: Accredited Gender, Sex & Relationship Diversities Therapist (AGSRDT) and Advanced Accredited Gender, Sex & Relationship Diversities Therapist (AAGSRDT).

Initial accreditation for both categories runs for three years, following which there is a reaccreditation procedure. Practitioners with AGSRDT accreditation may apply at any time to upgrade to AAGSRDT status.
